

ARIA VENTILATORI FAN COMPANY CEILING FANS

— *One Year Limited Warranty* —

The Aria Ventilatori Fan Company provides the following limited warranty to the user or consumer purchaser of this Aria Ventilatori ceiling fan:

If your Aria Ventilatori ceiling fan fails at any time within one (1) years after the date of sale to you due to a defect in material or workmanship, labor to repair the defect will be provided free of charge at our nearest service center located in Atlanta, Georgia. To obtain servicing, contact the Aria Ventilatori Fan Company. Please call 888-640-5550. You must contact us prior to shipping your fan part or fan to us. If we authorize you to ship it to us, you will be responsible for all insurance and freight or other transportation charge to our service center.

If any external part, easily removed, such as fan blades, of your Aria Ventilatori ceiling fan motor fails, you will need to box carefully the defective part, and ship it to our service center. You will be responsible for all insurance and freight or other transportation charges to our service center.

If any internal part or external part not easily removed, of your Aria Ventilatori ceiling fan motor fails, you will need to box carefully the entire fan, and ship it to our service center. You will be responsible for all insurance and freight or other transportation charges to our service center.

Aria Ventilatori ceiling fans must be returned in their original box with original packaging to avoid damage to the ceiling fan during transport. Failure to properly package ceiling fan for transportation or shipping that results in damage to parts or finishes will not be covered by Aria Ventilatori Fan Company, and we will not be responsible for any such damage.

Proof of purchase is required when requesting warranty service. The purchaser must present the sales receipt or other documentation that establishes proof of purchase.

We will return your Aria Ventilatori ceiling fan, or parts, prepaid, once repairs have been made.

This warranty excludes and does not cover defects, malfunctions or failures of any Aria Ventilatori ceiling fan which were caused by repairs by persons not authorized by us, use of parts or accessories not authorized by us, mishandling, improper installation, modifications or damage to the Aria Ventilatori ceiling fan while in your possession, or unreasonable use, including failure to provide reasonable and necessary maintenance.

IF THE USER OR CONSUMER PURCHASER CEASES TO OWN THE FAN, THIS WARRANTY AND ANY IMPLIED WARRANTY WHICH THEN REMAINS IN EFFECT, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE VOIDED. NO WARRANTY, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, IS MADE IN RESPECT OF THE FINISH ON ANY METAL PORTION OF THE FAN.

THIS WARRANTY IS IN LIEU OF ALL OTHER EXPRESS WARRANTIES. THE DURATION OF ANY IMPLIED WARRANTY, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, IN RESPECT TO ANY ARIA VENTILATORI MOTOR OR FAN PART, IS EXPRESSLY LIMITED TO THE PERIOD OF THE EXPRESS WARRANTY SET FORTH ABOVE FOR SUCH MOTORS OR OTHER PARTS.

IN NO EVENT SHALL ARIA VENTILATORI FAN COMPANY BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES.
